

Nära Horton is open 51 weeks a year from 7:00am - 6:00pm Monday to Friday, Our Full Day session runs from 8:00am to 6:00pm and Morning, Afternoon and Early Start sessions are also available.

Discounts

We offer a sibling discount of 10% on the cheapest child's fees.

A discount is also offered on children attending a total of 5 Full Day sessions on a fully private basis.

Closure days

Our nursery is open all year-round to meet the needs of working families, closing only during Christmas week and on Bank Holidays. When we set our fees each year, we take into account these closures, so your fees don't change in those months.

All-inclusive service

We want to make life simple for our families, so our fees include:

- Infant formula, milk, home-cooked (paediatric nutritionist approved meals and snacks
- Health and hygiene consumables including nappies, wipes, nappy cream and sun cream.
- Our incredible range of Nära Enrichment activities, including: Forest School, Yoga, Early Photography, Jabadao, Cooking Station, Makaton, Emotion Coaching, Big School Adventure, Play and Say, Children's Pottery, Safety Scouts, and Woodwork, and other additional activities.

Funding

We are pleased to provide the government's 15 Hours and 30 Hours funding offer for all eligible children aged 9 months and above. Our Parents' Guide to Early Years Funding and Other Help With Childcare Costs contains everything you need to know about how to check eligibility, when and how to apply, and how we offer funding.

The government funded hours are 15 and 30 hours during term time only. To meet the needs of working families and because we are open for 51 weeks of the year, our stretched funding offers up to 11.18 hours / 22.35 hours weekly entitlement for 15 and 30 Hours respectively across all 51 weeks we are open. Parents can apply up to 10 hours of funding per day, during our regular session times.

Eligible working families can use their full 22.35 hours weekly entitlement by applying the first 20 funded hours towards 2 full day sessions, and the balance 2.35 hours can be taken over a full day or partial day session. Families eligible for 11.18 hours funding per week can apply the funded hours across a mix of full day or partial day sessions.

Government funding is not intended to cover the cost of meals, other consumables, or activities that go beyond the requirements of the Early Years Foundation Stage such as our Enrichment activities. Accordingly, as part of our all-inclusive, integrated service, we apply a charge for these to each funded session. If you're considering options other than our all-inclusive, integrated offer, please speak with the nursery manager.

Costs detailed below are based on a full day with 10 hours of funding. For a half day or part-funded session, our invoicing system pro-rates the charges. Home-cooked food and snacks: £8.50, Health and Hygiene consumables £2.50, Additional activities £8.00.

Please contact the nursery manager or refer to the nursery's funding agreement for examples of how to calculate your estimated monthly costs inclusive of any applicable charges for your desired attendance.

Additional Information

Fees are typically reviewed in April each year in line with our Terms and Conditions. We charge a non-refundable registration fee of £75.00 to reserve a place and a refundable deposit of £100 for attending 6 or fewer sessions, and £200 for attending 7 or more. We invoice parents monthly, charging the same amount each month allowing you to plan your finances. We accept payment via Tax-Free Childcare, bank transfer, or childcare vouchers.
